Incident to be logged in accident book.</p> <p>In the event of the tarantula flicking Urticating hairs audience will be advised to wash hands in warm soapy water to remove any hairs and will be advised that these can also cause mild irritation to the skin. The tarantula is not to be held near people's faces to prevent inhalation of any hairs as this can cause irritation to the airway.</p> <p>The tarantula will be kept in a secure enclosure and will be supervised at all times by the Ranger. Only the Ranger is allowed to remove the tarantula from its enclosure.</p>	Ranger
Royal Python	Bite Escape	Audience and Ranger	Low	<p>Only nonvenomous snakes are used the Ranger will assess the Royal Pythons behaviour before handling. The Ranger will keep the snakes head away from the audience, Royal Pythons are docile in nature and as such are unlikely to bite. In the event of a bite/strike the Ranger will secure the animal immediately and medical assistance will be given to the individual bitten. Incident to be logged in accident book.</p> <p>The Royal Python will be kept in a secure enclosure</p>	Ranger

				and will be supervised at all times by the Ranger. Only the Ranger is allowed to remove the Royal Python from its enclosure.

The Ranger will keep the snakes head away from the audience, corn snakes are docile in nature and as such up unlikely to bite. In the event of a bite/strike the Ranger will secure the animal immediately and medical assistance will be given to the individual Bitten. Incident to be logged in accident book.</p> <p>The corn snake will be kept in a secure enclosure and will be supervised at all times by the Ranger. Only the Ranger is allowed to remove the corn snake from its enclosure.</p>	Ranger
Hermann Tortoise	Bite/Scratch Escape	Audience and Ranger	Low	<p>The Ranger will instruct and supervise on the correct handling of Hermann tortoise if necessary the tortoise will be placed in a basket to prevent it from scratching individuals. Incident to be logged in accident book.</p> <p>Hermann tortoise will be kept in a secure enclosure and will be supervised at all times by the Ranger. The chameleon will be placed on a branch and will not be handled directly in the event of an individual being bitten or scratched the animal will be placed easing enclosure immediately and medical assistance will be given to the individual injured. Incident to be logged in accident book.</p> <p>The chameleon will be kept in a secure enclosure and will be supervised at all times by the Ranger. Only the Ranger is allowed to remove the chameleon from its enclosure.</p>	Ranger

Spread of disease and bacteria (salmonella)	Audience and Ranger	Low/Medium	<p>The Ranger will wash their hands thoroughly directly before the presentation commences and directly after the presentation as ended. The Ranger will give the Health and safety brief before the animal handling experience starts this will include the washing of hands before and after handling the animal. Antibacterial gel will be used in between handling of each animal to reduce cross contamination. It is recommended that the venue must have hand-washing facilities.</p> <p>All animals can carry disease and bacteria; and are checked on a regular basis for health and illness.</p>	Ranger/Party organiser

			<p>Animals will be provided with vaccinations where necessary. Faecal samples will be collected from reptiles and tested on a regular basis.</p> <p>All animal enclosures and transport enclosures our regularly disinfected and cleaned substrates are replaced regularly to prevent spread of bacteria.</p> <p>Any sick or unwell animals will not be used in any presentation.</p>	
Faecal/Urinate (A dry, chalky substance called a "Urate" which is essentially excreted <i>uric acid</i>)	Audience and Ranger	Low/Medium	<p>Animals may sometimes poo as a defence mechanism when been handled. In the event of an animal poo's either near or on an individual the Ranger will clean this up immediately and disinfect the area. Bacterial gel Will be used on hands.</p>	Ranger
Allergies	Audience	Low	<p>It is recommended that Rangers are made aware of any potential allergies individuals may have. Venue staffs are responsible for delivering any specific first aid encoding depends for allergies are similar ailments.</p>	Ranger/Party organiser
Phobias	Audience	Low	<p>The audience will be introduced to each animal in turn. Individuals will be invited to handle the animals but are not obliged to hold the animal. If the individual does not want to hold an animal they will be asked to fold their arms. Anyone with severe or extreme phobias needs to be brought to the attention of the Ranger on arrival prior to the handling session commencing. The Ranger has the rights to remove an animal from the presentation if the audience or individual seems particularly stressed or uneasy.</p>	Ranger/Party organiser
Child and vulnerable persons protection	Audience	Low	<p>All Rangers have a valid DBS check renewed every three years. Captivating Creatures have up to date child protection and safeguarding training. All Ranges will be dressed in Captivating Creatures Branded uniforms.</p>	Ranger

Animal transport	Ranger	Low	All our animals are transported in appropriate and secure enclosures, ensuring adequate heating is supplied and ample food and water is provided for the animals. Animals are not transported for long periods of time and animals will be rotated periodically in order to prevent being stressed. Public Events	Animals/Ranger	Low	<p>For closed groups a maximum of 30 per session is recommended. A representative of the event should control the general public. The display will be held in the gazebo when outdoors. In the unlikely event that there are too many people the Ranger will restrict access to the animals and move them to a safe and secure place. The Ranger reserves the right to withdraw any animals from any public events on the grounds of animal welfare if required.</p> <p>In the event of any adverse weather conditions the animals will be kept in their enclosures and access will be restricted. An electricity supply must be provided in order to provide adequate heat sources for the animals; the Ranger will conduct a dynamic risk assessment if necessary on the day of the event taking into account weather conditions and temperature. The Ranger will assess whether it is appropriate or not and whether an alternative locations can be arranged.</p> <p>The Ranger will handle only one animal at any one time. The Ranger will remain in full control of the animal and the public will not be allowed to hold the animal independently. All animal enclosures are kept secure at all times and checked regularly by the Ranger. Animals will be accounted for before during and after the event. In the unlikely event that an animal escapes the Ranger will locate the animal promptly and using safe capture techniques will be returned to its enclosure.</p>	Ranger/Venue Staff
